Pool opens Memorial Day weekend through first week in August.

## **Membership Conditions & Privileges**

First month's dues, Initiation fee, Trail Fee, Cart Shed Lease (if applicable), copy of member's ID (driver's license, etc) and completed application must be submitted for membership consideration.

All above memberships allow guest play, \$30\* for Greens fee (18 Holes Only), \$25 for Additional Greens Replay Fee – All Day (for additional holes after first 18, all day play, includes cart rental), \$10\* for Pool guest fee

*(\*With limitations - In-County: Golf guest 1x per year, Pool guest 3x per year (max of 3 guest per visit). Out of County: Golf & Pool guest unlimited x per year).*

Carts are available to rent daily for \$20 (18 holes only, over 18 holes refer to the Additional Greens Replay Fee – All Day for \$25.)

All Members are required to pay a non-refundable Annual Assessment Fee (used for capital improvements) each calendar year following membership acceptance. *(For example, Year 2025 Assessment Fees were \$250 for Full Members and \$125 for Social Members which were due in March of 2025.)*

All Golf members are required to pay a Trail Fee of \$136.56 per calendar year.

Cart Space leases, if available, are \$125 per calendar year.

All Member Dues are due the 1<sup>st</sup> of each month and other Charges the 15<sup>th</sup> of each month. ACH/bank card authorization is required for payment of monthly dues and any misc items charged to Member account. Late fee of 5% will be assessed on balances past 30 days.

## **General Conditions of Membership**

1. Initiation, Annual Assessment, Trail and Cart Shed fees are non-refundable.
2. All new members are required to have a credit card or ACH payment on file as all monthly charges will be automatically processed for payment on the 1<sup>st</sup> of every month. A paid monthly statement will be emailed to you.
3. Charging privileges for bar purchases, greens fees, cart rental fees or other miscellaneous items will be allowed only if a credit/bank card is kept on file for your member account. Charges will be invoiced on the 1st of each month and processed for payment the 15<sup>th</sup> of each month.
4. There is no termination fee. **Cancellation requests must be submitted within 30 days of the requested cancellation date.** For Full memberships with golf, there is a 12-month waiting period to re-join.
5. Bills past due more than 60 days will be considered cause for suspension. Past due fees of 5% will be applied after 30 days. If it should become necessary for the Club to institute proceedings to collect any delinquent accounts, the member shall be liable for all fees and cost including any attorney's fees associated.
6. Members agree to allow Somerville Country to periodically email newsletters or relevant club information to email address on file.
7. The club will not be responsible for loss or damage to property of members on the Club property, whether in lockers, bag storage or elsewhere. However, the club will take measures to keep property secure by locks, alarm systems and 24-hour camera surveillance of select areas around the property.
8. No solicitations are to be made on the Club's property at any time.
9. No reprimand shall be given to employees by any members of the club. Complaints concerning the normal operations of the Club, the Club employees and other matters are to be made in writing, signed and directed to the office or Board of Directors.
10. In the event of a divorce, the membership may be retained by the applicant or as provided by court orders. Dependent members may reapply for membership consideration.
11. Applicant understands that membership may be suspended or terminated without refund if Club rules or policies are violated by a member and/or their guest.
12. All Members and guests must adhere to posted signs concerning the golf course, pool or clubhouse.
13. Golf members agree to use appropriate etiquette on the golf course. Large groups of 5 or more are prohibited unless prior authorization is granted by the Board of Directors. Slow players must let faster players pass through.
14. Pool guests of 4 or more for pool parties must gain prior authorization from the Pool Manager or Board of Directors. Additional fees may apply.
15. The pool and golf course can be closed without notice to ensure the safety of the members. This includes availability of lifeguards at the pool, inclement weather or unforeseen maintenance.
16. Tournaments are held during the year for members and non-members. The golf course will be closed for play during tournaments.
17. Alcoholic Fee – BYOB Fee \$100 per year for consuming own alcohol on premises. If the fee is not paid and alcohol is consumed, a penalty may be applied to your account.
